ARTICLE 1	
SECTION 1	THIS ORGANIZATION SHALL BE KNOWN AS THE NCSU FILMMAKERS.
SECTION 2	THE PURPOSE OF THIS CLUB SHALL BE TO PROMOTE AND ORGANIZE THE VIDEO AND FILMMAKING ACTIVITIES OF ITS MEMBERS.
ARTICLE 2	
SECTION 1	ACTIVE MEMBERSHIP SHALL BE OPEN TO ALL REGULARLY ENROLLED STUDENTS. FACULTY AND STAFF OF NCSU INTERESTED IN ANY ASPECT OF VIDEO AND FILMMAKING. ASSOCIATE MEMBERSHIP IS OPEN TO ALL OTHERS INTERESTED IN THE CLUB'S ACTIVITIES.
SECTION 2	IN ORDER TO BECOME A MEMBER, AN APPLICATION MUST BE COMPLETED AND DUES PAID.
ARTICLE 3	
SECTION 1	THE ELECTIVE OFFICERS FOR THE NCSU FILMMAKERS SHALL BE: PRESIDENT, VICE-PRESIDENT, SECRETARY, AND TREASURY. APPOINTED OFFICERS SHALL BE SELECTED BY THE ELECTIVE OFFICERS.
SECTION 2	THE ELECTIVE OFFICERS SHALL BE ELECTED BY THE ACTIVE MEMBERS TO SERVE A TERM OF ONE YEAR BEGINNING SEPTEMBER.
ARTICLE 4	
SECTION 1	DUES FOR THE CLUB SHALL BE TWENTY-FIVE DOLLARS PER MEMBER PER SEMESTER.
ARTICLE 5	
SECTION 1	AMENDMENTS TO THE CONSTITUTION OR BY-LAWS SHALL BE PRESENTED BY MEMBERS OF THE CLUB IN WRITING AND READ AT A REGULAR MEETING BUT SHALL NOT BE VOTED UPON UNTIL THE NEXT REGULAR MEETING, AND THEN ONLY AFTER INFORMING EACH MEMBER FOR THE PROPOSED AMENDMENTS. A MAJORITY OF 2/3 OF THE MEMBERS PRESENT AND VOTING SHALL BE REQUIRED.
