

**NCSU Campus Ministry**  
Constitution

- I. NCSU Campus Ministry
  - A. This organization shall be known as the NCSU Campus Ministry.
  - B. The NCSU Campus Ministry is a chapter under the direction of the Upper Room Campus Ministry and is directly affiliated with Upper Room Church of God in Christ. The Upper Room Campus Ministry has established Campus Ministries at the following Universities: NCSU, UNC, Shaw and NCCU.
  - C. The purpose of this ministry shall be to teach the sound doctrine of the Holy Bible, spread the gospel of Jesus Christ, and glorify God through prayer and praise and worship.
- II. Membership
  - A. Membership shall be open to all regularly enrolled college students who are interested in learning about the sound doctrine of the Holy Bible, apply it to their lives, and express a sincere interest for working in the ministry.
  - B. The Upper Room Campus Ministry Director shall select the method by which membership in the club shall be approved.
- III. Officers
  - A. The officers of the NCSU Campus Ministry shall consist of four positions: President, Vice President, Publicity Chair and Publicity Co-Chair. The general duties of the President is to oversee Bible study, ensure that all planned activities are in order, and follow up with other officers to make sure the needs of the Campus Ministry are being met. The general duty of the Vice President is to assist the President in all matters, and fill the President's duties in their absence. The general duty of the Publicity Chair is to oversee and execute all publicity requests. The general duty of the Publicity Co-Chair is to assist the Publicity Chair in all matters.
  - B. Term of office shall be one academic school year.
  - C. Provisions for removal of an officer shall be handled at the discretion of the Campus Ministry Director.
- IV. Dues
  - A. Dues for the NCSU Campus Ministry shall be in the form of special assessments.
- V. Amending the Constitution and By-Law's
  - A. The constitution may be amended by the President of the NCSU Campus Ministry.
- VI. Meetings
  - A. Regularly scheduled meetings of this organization shall be held on a monthly basis. Members shall be notified of upcoming meeting via e-mail from the Upper Room Campus Ministry Director.
- VII. Committees
  - A. The NCSU Campus Ministry shall make provisions for any standing committees when needed and/or for forming any special committees when necessary.

**Upper Room COGIC Campus Ministry  
Constitution**

- I. Name and Purpose
  - a. This organization shall be known as the Upper Room COGIC Campus Ministry.
  - b. The purpose of this ministry shall be to teach the sound doctrine of the Holy Bible, spread the gospel of Jesus Christ, and glorify God in prayer and praise and worship.
- II. Membership
  - a. Membership shall be open to all regularly enrolled students who are interested in learning about the Bible and how it relates to their lives as college students.
- III. Officers
  - a. The officers of this organization shall consist of four positions: President, Vice President, Public Relations Chair and the Public Relations Co-Chair. The general duties of the President is to oversee Bible study to make sure it starts and ends on time, ensure that all planned engagements are arranged in advanced and in order, and follow up with other officers and committees to make sure the needs of the ministry are being met. The general duty of the Vice President is to assist the President with their duties and act as President in their absence. The duty of the Public Relations Chair is to make sure that all areas of PR are used and updated as often as needed. The duty of the Public Relations Co-Chair is to assist the PR Chair in anyway possible.
  - b. Term of office shall be one school year.
  - c. Provisions for removal of an officer shall be handled by the discretion of the Advisor or Staff member.
- IV. Amending the Constitution and By-Laws
  - a. The constitution may be amended by a majority vote of the Campus Ministry leaders.
- V. Meetings
  - a. Regularly meetings of this organization shall be held monthly. Members shall be notified of upcoming meetings via e-mail.
- VI. Committees
  - a. The ministry shall make provisions for any standing committees needed and/or forming any special committees when needed.
