

The Virtue Alliance at NCSU - Club Constitution

Dated: February 18, 2003

Article One: Name and Purpose

Section One: This Organization shall be known as the NCSU Chapter of The Virtue Alliance.

Section Two: The purpose of this Organization is to attempt to inspire students and the public to volunteer their time in non-profit groups or charities. Likewise, we will try to demonstrate the drive to volunteer through our own humanitarian projects.

Article Two: Membership

Section One: Membership for the NCSU Chapter of The Virtue Alliance shall be open to all regularly enrolled students or faculty members who are interested in working towards positive social change in their local community.

Section Two: Membership in the NCSU Chapter of The Virtue Alliance is dependent only on relatively frequent attendance to club events and meetings.

Article Three: Officers

Section One: The officers for this club shall be the founding members of the club. When the founding members of the club are no longer students of North Carolina State University, new officers shall be elected.

Section Two: Any new officers shall be selected on basis of experience by the old officers, when the old officers are no longer able to serve.

Article Four: Dues

Section One: Dues for the NCSU Chapter of The Virtue Alliance shall be \$10 per semester.

Article Five: Amendments to the Constitution

Section One: Amendments to the constitution may be presented by any member who has paid dues at any time. Amendments will be voted on between the club officers, and will be passed should 2/3 of the officers agree upon its passing.

Article Six: Meetings

Section One: The NCSU Chapter of The Virtue Alliance shall meet weekly.

Article Seven: Committees

Section One: New committees shall be formed for each new project conducted.
