## IMPACT Christian FellowshipConstitution

Article 1 Name, Purpose, & Affiliation

Section 1—This organization shall be known as IMPACT Christian Fellowship.

Section 2—The purpose of this club shall be to present and discuss the Christian worldview with non-Christians in order to encourage faith in Jesus Christ and to provide Christian students with biblical fellowship and sound theological teaching.

Section 3—IMPACT is affiliated with Community Life Church in Apex, NC.

Article 2 Membership

Section 1—Membership shall be open to all regularly enrolled students who are interested in Christianity.

Associate membership is open to any non-student interested in Christianity.

Section 2—Recognition of membership will be determined by regular attendance at IMPACT Christian Fellowship events and by a signed declaration-of-intent to be an official member. Willful non-attendance over any three-month period, apart from incapacity, will result in loss of membership. Discharged members are welcome to return to meetings and revive membership at any time.

Article 3 Officers

Section 1-The elective officers of this club shall be the President, Vice-President, Treasurer, and Secretary. The president runs the meetings, the vice-president helps and fills in when the president is gone, the treasurer keeps track of the money, and the secretary does all the official recording. Section 2—The officers shall be elected by the club members to serve a term of one year, beginning September 24.

Article 4 Dues

Section 1-No dues are required.

Article 5 Amending the Constitution and By-laws

Section 1-Amendments to the constitution or by-laws shall be presented by members of the club in writing and read at a regular meeting by shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A majority of 2/3 of the members present and voting shall be required.

Article 6 Meetings

Section 1—The club shall meet every Tuesday night at 7:00 unless otherwise announced.
