## **Article I Name & Purpose**

### **Section 1**

This organization shall be known as the Wolfpack Environmental Student Association (WESA).

### **Section 2**

The purpose(s) of this club shall (will) be to promote campus environmental awareness and environmental protection, to form networks with themes related to the environment and natural resources within NCSU's colleges, and to engage other universities (both national and internationally) in endeavors to manage environmental and natural resources. The Club will participate in projects and initiatives that contribute to better use of environmental and natural resource use at NC State University, and when appropriate, with related efforts in Raleigh, Wake County, and beyond.

## **Article II Membership**

### **Section 1**

Membership shall be open to all regularly enrolled students who are interested in promoting stewardship of environmental and natural resources, in increasing awareness of environmental and natural resource issues, and in fostering activities that impact the use of environmental and natural resources.

### **Section 2**

Means of selection of members: WESA will elect its officers annually through votes of the current enrolled club members.

## **Article III Officers**

### **Section 1**

The elective officers for this club shall be President, Vice President, Secretary, and Treasurer. The roles of these officers will be those traditionally understood. The initial officers of the Club will be, respectively Abraham V. Sutfin (President), Sarah L. Dombrose (Vice President), Catherine Frock (Secretary), and Christopher Doerner (Treasurer). The appointed officers will serve for the first year, with subsequent officers elected by the Club members. In the event that one of these roles needs to be filled because of an emergency situation the replacement officer shall be elected by vote of the current members.

### **Section 2**

The officers shall be elected by the club members to serve a term of one year, beginning August 18, 2007 and will end August 18, 2008. In order to assist newly elected officers, elected officers shall have at least 3 full semesters left at NCSU. This will give the new officers no less than one full semester to gain understanding of the goals and practices of the WESA. Elections shall take place in April of the current semester.

## **Article IV Dues**

### **Section 1**

There will be no dues for WESA club members.

## **Article V Amending the Constitution and by-laws**

### **Section 1**

Amendments to the constitution or by-laws shall be presented by members of the club in writing and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A majority of 2/3 of the members present and voting shall be required.

## **Article VI Meetings**

### **Section 1**

The club shall meet monthly. Additional meetings may be scheduled if announced one week in advance. Committees within the Club will meet as needed, and will report at Club meetings.

## **Article VII Committees**

### **Section 1**

The club shall make provision for any standing committees needed and/or for forming any special committees when needed.
