

CONSTITUTION OF
THE WOLFPACK RIFLE AND PISTOL CLUB

ARTICLE 1: NAME AND PURPOSE

Section 1: The organization hereby constituted shall be known as the Wolfpack Rifle and Pistol Club ("WRPC").

Section 2: The mission of WRPC shall be as follows:

- a) To provide North Carolina State University – Raleigh ("NC State") and the surrounding community with a publicly visible forum for education in the skillful and responsible use of firearms in competition, hunting, and the defense of self and others;
- b) To advocate and defend the proposition that both the moral law and the Second and Fourteenth Amendments to the United States Constitution guarantee the individual right to possess and use firearms in defense of self and others; and
- c) To engage and recruit the students, faculty, and staff of NC State to assist in a) and b) above.

Section 3: WRPC shall be nonprofit and nonpartisan and shall not support or oppose any candidate for public office or any legislation pending in any governing body.

ARTICLE 2: ORGANIZATIONAL STRUCTURE

Title 1: Members

Section 1: The members of WRPC shall be those students, faculty, and staff of NC State and members of the surrounding community who have

- a) registered as members, with signing this Constitution for the purpose of its adoption being sufficient to constitute registration as a member;
- b) paid any required dues for the current fiscal year, with fiscal years of WRPC to commence September 1 and end August 31;
- c) if applicable, be in good academic standing as defined by NC State; and
- d) demonstrated, to the satisfaction of a majority of the Directors of WRPC, their ability to handle firearms in a safe and responsible fashion,

provided that WRPC may restrict the eligibility of persons not students at NC State if doing so is necessary for compliance with NC State regulations regarding registered organizations.

Title 2: Directors

Section 1: WRPC shall be led by a Board of Directors. Eligibility for service on the Board of Directors shall be limited to members of WRPC who are full-time students at NC State.

Section 2: The Board of Directors of WRPC shall consist of a President, a Chairman, a Secretary, and a Treasurer:

- a) The President shall preside over the meetings, events, and recruiting efforts of WRPC.
- b) The Chairman shall be the official spokesperson responsible for preparing media releases and other communications and issuing such communications subject to their approval by one other Director.
- c) The Secretary shall be responsible for keeping minutes of meetings at which official decisions of WRPC are made; copies of media releases and other official statements issued by WRPC; records of all known press coverage mentioning WRPC and/or its officers in their official capacity; and, in cooperation with the Treasurer, maintaining a list of current and former members.
- d) The Treasurer shall have the following responsibilities: to manage the bank accounts and other financial assets of WRPC; to disburse payment for such expenses as are approved by its Directors; to oversee the use of its non-financial assets other than the records to be kept by the Secretary; and, in conjunction with the Secretary, to maintain a list of current and former members.

Section 3: In fiscal years of WRPC following the one in which WRPC is founded, eligibility to serve as a Director shall be limited to members who attended half or more of all meetings and half or more of all events during the previous fiscal year.

Section 4: The Board of Directors of WRPC shall serve terms of one fiscal year, to commence at the first meeting held in a given fiscal year. Elections for each term shall be held at a date between seven days and one day before the first final examination of the previous NC State spring academic term, except that the first elections of WRPC shall be held on a date to be set by the Board of Directors and being no later than the end of the calendar month in which this Constitution is signed.

Section 5: Directors shall be elected by nomination and simple majority vote at the aforementioned meeting; if no nominee receives a simple majority, the nominee or nominees with the fewest votes shall be removed from consideration and a runoff vote from among the remaining nominees shall be held. A Director shall be replaceable for the remainder of his or her term by a two-thirds majority vote at any meeting approving the motion that that Director shall be replaced with a specific qualified person named in that motion. In each case, voting shall be by secret ballot.

Section 6: Until the meeting for first elections mentioned in Section 4, WRPC's President shall be Bill Reynolds, its Chairman shall be Jenna Matino, its Secretary shall be Matt Gifford, and its Treasurer shall be Jennifer Marshall.

Title 3: Decisions and Official Actions


- Section 1:* Day-to-day decisions of WRPC, including but not limited to scheduling meetings and events, shall be made by simple majority vote of its Board of Directors. In the event of a tie, the side on which the President votes shall prevail.
- Section 2:* Dues for a fiscal year may be set once per fiscal year by simple majority vote of members present at the meeting during which the vote occurs. Members who join in the second half of a given NC State academic year may be admitted for the remainder of that academic year by paying one half of the dues set for the fiscal year in progress.
- Section 3:* Bylaws consistent with this Constitution may be adopted and/or amended by a two-thirds majority of members present at a meeting.
- Section 4:* This Constitution may be amended by the concurrence of a two-thirds majority of members present at a meeting with a simple majority of Directors present at the same meeting. In the event of a tie among the Board of Directors, the amendment shall fail.

ARTICLE 3: ACTIVITIES


- Section 1:* Activities of WRPC shall consist of meetings, at which matters of internal governance shall be discussed, and events, at which members and others in attendance shall further the mission of WRPC.
- Section 2:* Meetings of WRPC may be closed to non-members by simple majority vote of members present.
- Section 3:* Subject to any bylaws to the contrary, events of WRPC shall be open to public attendance and participation, subject to a) the payment of any participation fees which may be set by the Directors at their discretion, provided that such fees shall be to cover the participation costs and not for profit, and b) the signature of a document releasing and holding harmless WRPC, its members, and NC State from all legal liability related to or arising from their participation in WRPC.

ARTICLE 4: ADOPTION

- Section 1:* This Constitution shall be effective upon its signature by the four persons named herein as President, Chairman, Secretary, and Treasurer of WRPC, provided that those persons are eligible for membership in WRPC.




