Constitution Wolfpack Skydiving Club 3/24/08

Article I

Section 1

This organization shall be known as the <u>Wolfpack Skydiving Club</u>. Section 2

Section 2

To allow members of North Carolina State University the opportunity to experience the sport of skydiving, and to provide an opportunity for people to share their interest in the sport, allow a spirit of competitiveness, and to further the bond created by skydiving together.

Article II

Section 1

Membership shall be open to all regularly enrolled students, and alumni of NCSU who are interested in the Sport of Skydiving.

Section 2

This club is open to all students/alumni with an interest in learning to skydive, and those who already skydive.

Article III

Section 1

This club will be run by 4 elected members who are currently enrolled in NCSU and in good academic standing.

President: duties- Represent the club to all other official organizations, call meetings, oversee the function of the club.

Treasurer: duties- Honestly and truthfully manage the club's funds in order to pay for the club's expenditures.

Secretary: duties- Record and retain records of the club's meetings and manage the club's website.

Recruiter: duties- To organize events that will raise awareness of the club and promote more students to join.

Section 2

The officers shall be elected in March for the following academic year. Any active member is eligible to run for office. Officers are elected by a majority of the voting members on a day when more than half are present and voting. If more than two people are running for an office and no one wins a majority, then the person with the fewest votes is dropped from the ballot and votes are cast again. Officers may be removed at any time by a two/thirds vote of the members. Candidates for President must have been a member of the club for at least one year and must have completed a Category "A" Skydive in accordance with the ISP (Integrated Student Program).

Article IV

Section 1

Dues for this club shall be \$25 per semester. All finances for the club will be obtained through NCSU student activity funding, dues, and other club-approved fund-activities. Section 2

The funds that this club has available will be used to raise awareness of the club, help fund members' Accelerated Free Fall Training, and provide aid for a Wolfpack Skydiving team at competitions.

Section 3

The amount of funds that will be used for advertising, and for competitions will all be determined on a time to time basis by a majority vote at one of the meetings. These expenditures will be presented by the Treasurer and any member will be able to submit a request for funding through the Treasurer.

Section 4

Members of the Wolfpack Skydiving Club that are going through Accelerated Free Fall will be able to get a set amount of funding through the club as follows:

Category A - \$30

Category B - \$10

Category C (2 jumps) - \$10 per skydive

Category D (2 jumps) - \$10 per skydive

Category E (3 jumps) - \$10 per skydive

The funds that are specified above only apply to first time attempts for the skydive and do not apply to repeats of a single level.

Article V

Section 1

Amendments to the constitution or by-laws shall be presented by any member of the club in writing, and read at a regular meeting but shall not be voted upon until the next regular meeting, and then only after informing each member of the proposed amendments. A majority of 2/3 of the members present and voting shall be required.

Article VI

Section 1

At least one general club meeting will be held each semester on the NCSU campus. Meetings shall be organized and presided over by the President, unless absent, in which case the Secretary shall preside. All decisions shall be made by majority vote of the members present.

Article VII

Section 1

In the event a special committee can be formed. The purpose and duration of this committee will be agreed upon by a majority of members at a given meeting.

Article VIII

Section 1

Members of this club must become members of the United States Parachute Association within the completion of 5 Accelerated Free Fall Skydives.
