

AGREEMENT

This memorandum of agreement made between the Crop Science Department of The North Carolina Agricultural Experiment Station and under the direction of G. C. Klingman (hereinafter referred to as "The Crop Science Department") and AmChem Products, Inc. witnesseth that:

Whereas, AmChem Products, Inc. is interested in research dealing with the effect of various herbicides upon the response to various plants and the control of weeds therein;

Whereas, the Crop Science Department has available facilities and experience in conducting research work in evaluating the effectiveness of such herbicides;

Now, therefore, in consideration of the premises and reciprocal covenants hereinafter set forth:

ARTICLE I

1. The Crop Science Department agrees to undertake research work during the period beginning January 1, 1966 and ending December 31, 1966, in evaluating the effect of certain herbicides on weeds and crop plants.

2. The Crop Science Department agrees to provide facilities, including the conventional equipment required in the conduct of the research work defined in the previous paragraph.

3. The Crop Science Department agrees to provide labor, technical and supervisory personnel and supplies to be used in the conduct of the research, other than the herbicides which will be supplied by AmChem Products, Inc.

ARTICLE II

1. AmChem Products, Inc. agrees to pay the Crop Science Department the sum of fifteen hundred (\$1500) dollars to be applied to the cost of carrying out the research work under this agreement including such items as cost of labor, technical assistance, special equipment, and supplies including overhead for indirect costs.

2. AmChem Products, Inc. agrees to provide reasonable amounts of the herbicides referred to in Article I.

ARTICLE III

1. Detailed records of the experiment work shall be maintained by the Crop Science Department and shall be made available to AmChem Products, Inc. The Crop Science Department will render a final report at the conclusion of the work.

MEMORANDUM OF AGREEMENT
BETWEEN
AMCHEM PRODUCTS, INC., OF AMBLER, PENNSYLVANIA
AND THE
NORTH CAROLINA AGRICULTURAL EXPERIMENT STATION, RALEIGH, NORTH CAROLINA

This Memorandum of Agreement concerns the furnishing of funds by Amchem Products, Inc., to the North Carolina Agricultural Experiment Station for the purpose of supporting research on herbicides.

The following conditions are mutually agreed to by Amchem Products, Inc., hereinafter designated "The Company," and the North Carolina Agricultural Experiment Station, hereinafter designated "The Station."

The Company agrees:

1. To place at the disposal of The Station the sum of \$2,500 this amount to be paid to The Station as soon as this agreement has been signed by both parties.
2. To furnish reasonable quantities of the herbicides to be evaluated.

The Station agrees:

1. To expend the funds furnished to support experimental work on herbicides.
2. To furnish a report to The Company at the conclusion of the work.

General:

This research is to concern the influence of various compounds on the uptake and/or translocation of herbicides. It is understood that any compound supplied by The Company for this study and found to be patentable will be considered an invention of The Company. Further, it is agreed that The Company will be given a first option to negotiate for any patent which arises from this study based on compounds entered by The Station unless such compounds have been supplied by a third party who has a specific interest in the study being undertaken.
