4-H AUTOMOTIVE SKILL DRIVING PROGRAM

This is to announce that there will be a North Carolina State Skill Driving Program conducted during the 1972 North Carolina 4-H Congress. The purpose will be to select the North Carolina 4-H Automotive Skill Driving Champions (one boy and one girl). These individuals will receive an expense-paid trip to participate in the Fourth Regional Invitational 4-H Automotive Care and Safety event to be held at the Rock Eagle 4-H Center, Eatonton, Georgia, September 18-20, 1972.

Eligibility:

- 1. Currently enrolled in the 4-H Automotive project.
- 2. Must have an accident-free (preventable) traffic and driving record for at least 12 months, or from the time the driving permit.
- 3. Up to one boy and one girl per county who has a North Carolina driver's license
- 4. Prior state Skill Driving Winners are ineligible to compete.

The North Carolina Program will consist of:

- A written exam scheduled for 4:00 p.m. July 24, 1972 to choose the top 12 contestants who will compete in the skill driving event.
- A skill driving event at 3:30 p.m., July 26, 1972, for the 12 contestants who scored highest on the written exam. (Attached is a sample copy of a skill driving course layout, judging and scoring sheet.)

SOUTHERN REGION 4-H LEADER FORUM

Participation for the past four years in the Southern Region 4-H Leader Forum at Rock Eagle 4-H Center, Eatonton, Georgia, has been limited to some 25 counties in the western part of North Carolina. This limitation has been necessary because of our low quota which meant cars rather than buses for transportation and limited donor support. Those who have participated had high praise for the program. As to educational value most leaders felt it superior to the National Forum.

The 1972 forum will be October 16-20 at Rock Eagle 4-H Center. I am pleased to announce that the forum will be offered to all counties this year. Naturally, there is still a quota (one bus - 37 people) and limited donor support. The support which we have will allow us to originate the bus in Asheboro with stops at Winston-Salem, Statesville, Hickory and Ashelicense was issued, including the driving ville. Dependent upon the location of leader participants an alternate route may be Asheboro, Lexington, Statesville, etc.

With financial support from the J. C. Penney may enter the program. Foundation and the North Carolina 4-H Development Fund the cost per leader should not exceed \$35.00 each.

Work day was held at Millstone 4-H Camp on May 27 with 14 4-H'ers and leaders from Anson County of the Olivet 4-H Club under the leadership of Mrs. Beverly Freeman and Mrs. Barbara Downer, leaders and a parent, Mrs. Becky Burr. Seventeen 4-H'ers from Richmond County from the Hoffman 4-H Club with Mrs. Mickie Teal as leader, and Invaders Club under the leadership of Mrs. Darsena Stanback and Mrs. Edith Whitaker from Richmond County were also helping. At Millstone they mowed grass, cleaned cabins, cleaned brush and debris, took down cabin shutters, installed new equipment, etc., and enjoyed hamburger and hot dog lunch as guests of the camp. They also enjoyed canoeing.

These work days were arranged at the request of agents in the area. There were other agents who had hoped to have groups to participate but had conflicts at that time.

REMINDER ON CAMP

Each camper is required to have a physical examination by a licensed physician within six months before camp and is also required to have a health history (a blue form supplied by the State 4-H Office). In addition each camper is required to receive a health checkup by a registered nurse upon arrival at camp unless they have had the physical within two weeks before departure for camp. We have a registered nurse at each camp for the check-up.

If all of your campers have had their physical examination within two weeks before coming to camp, I would appreciate your letting the camp director know so that he will not have to take this time to have the health check-up. The check-up will only take a few seconds and it is suggested that it be made by cabins with the forms given to the leaders to turn over to the nurse as their cabin group goes through. The health history is kept on file at the camp and is available to be used for any emergency treatment at the hospital or doctor's office while at camp. These forms will be kept for a period of several years. If the copy of the physical examination would be of help to the camper for future use, you may request that it be returned to you at the end of the week.

Please remember to write the camp director ten days before going to camp to let him know exactly how many campers you will have in attendance. It is necessary for ordering the food for your week at camp. I have instructed my directors to call you collect if they have not received this information at least one week prior to your arrival so expect such if you have not sent the report to him. Many of the meat orders have to be placed a full week before you arrive at camp.

Also remember to please bring that summary form that was sent to you by the camp staff early in May, filled out to help save time when settling your financial account with the director and giving a break-down report of your attendance.

Please also make plans to have some choice classes during your week at camp if you so desire. Bring any resource people with you or come prepared yourself to offer these

extra classes in addition to the ones that our staff have prepared for or to substitute for the staff if you so desire. Send to the director any plans that you have for special activities in camp or away from camp while there for the week.

I remind you again that we have horsemanship offered as an extra class at Penn and Schaub at \$12.00 per camper. Please notify your campers of this opportunity so that we can have as many as possible enjoying this special activity. This is an excellent value for the instruction and riding that is offered. Also remember to sign up all the campers you can for sailing at Mitchell Camp for only \$2.00 extra per camper.

The music program at Betsy-Jeff Penn is something very special. It is an activity that is provided by the North Carolina Extension Homemakers Clubs. We have been disappointed in the counties who have not notified the campers of this opportunity and have not signed up campers before they arrived at Penn. Be sure and inform your campers of this and use it as a means of recruiting boys and girls who are particularly interested in this special training in music. We have an outstanding music major teaching Song Leadership and Instruments. This extra activity is offered at no extra charge.

Don't forget to bring picture for your crafts. If you have not been able to write to your campers to notify them to bring picture, please get your co-workers or friends to gather pictures for you to carry with you to camp. We do not have them at camp. If you have an opportunity to send pictures to camp after you get back home, I know the crafts counselor will appreciate them.

We have been exceptionally pleased with the good plans that many of you have made before camp and hope that remainder of camping season will even be better.

Indiana

Monroe County, Indiana is in the process of looking for a 4-H Exchange Trip for the summer of 1972.

The program they've had the past few years has been a two-way exchange with each county hosting the other for about a week. The number of delegates has been between four and eight, primarily depending on what the other county wants. So far, their best schedule has been to host in late June or July, and visit in mid-August, but this is very flexible.

Monroe County has nearly 1,000 4-H'ers in a county of nearly 80,000 people and is the home of Indiana University. Their main 4-H projects are foods, clothing, crafts, beef, photography and several of the conservation projects. They plan to have veterinary science, bicycle and aquatic science all going soon. They have about 45 clubs and all volunteer leaders.

Their county is rather rolling for this part of the country and they have a few farms, RCA Color Plant, G. E., Westinghouse, Otis Elevator and the limestone quarries as their major industry. They have Lake Monroe, over 10,000 acres of water and Lake Lemon, 1,100 acres, for all sorts of fishing and recreational uses. These, with the University activities, give them quite a variety of leisure time choices.

Real briefly, that's Monroe County and Bloomington, Indiana!!!
