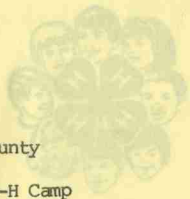

Over the past twenty years, the N. C. Division of Mental Health, Mental Retardation and Substance Abuse Services has sponsored the John W. Umstead Series of Distinguished Lectures as a way of bringing Mental Health personnel, and others interested in mental health, up to date on the latest in research and practice on a given topic. Each year the topic is different.

The 1985 lectures, to be held March 13-15 at the Raleigh Radisson and the Raleigh Civic Center Complex, will have as its topic Family Violence: Its Impact, Management and Prevention.

Because family violence permeates all levels of society and is the concern of many agencies and organizations, we are planning the lecture series for 800-1000 participants from law enforcement, criminal justice, the clergy, the medical community, public instruction, human service agencies and a wide variety of civic and citizen groups.

It is our intention to use the lecture series as the first step in developing a statewide comprehensive approach to the prevention of family violence.

The lecture series will consist of general sessions and workshops to address specifics of child, adolescent, spouse and elder abuse. We plan to draw heavily on the recent findings of the U.S. Attorney General's Task Force Report on Family Violence.
