LEGISLATIVE UPDATE

The 1987 N. C. General Assembly enacted several key provisions on behalf of the children of North Carolina. Several of these legislative priorities may directly or indirectly affect 4-H youth programing.

Establish 4-H Center Manager position at Betsy-Jeff Penn 4-H Center in Reidsville.

Funded independent legislative commission to examine social services, adolescent pregnancy prevention, adoptions, quality pre-school, youth suicide, children and youth, and mental health.

Adolescent pregnancy prevention funds were continued with a \$445,000 appropriation requested by Rep. Sidney Locks. Funded through the federal Social Services Block grant, the programs will now be administered by the Division of Health Sevices.

Receiving grants ranging from \$30,000 to \$5,000 will be Cherokee Boys Club, Carteret County Community Action, Macon County Programs for Progress, the N. C. Coalition on Adolescent Pregnancy, and health departments in Caldwell, Robeson, Harnett, Buncombe, Davidson, Greene, Bertie, and Scotland counties. Two programs, in Greene and Robeson counties, operate school health clinics. Funds cannot be used to purchase, prescribe, or dispense contraceptives on school property.

A "family support act" was sponsored by Sen. Russell Walker that continues medical assistance and provides limited wage assistance to AFDC recipients who begin working. The \$747,000 act also provides special grants for child care and transportation to teen AFDC parents enrolled in school or a schoolequivalency rogram.

The lawmakers appropriated \$500,000 for the biennium to the Children's Trust Fund for child abuse prevention community programs, but did not act on the governor's request for an income-tax check-off to set up a fund for child abuse victims.

Legislation was passed making minor technical changes in the omnibus day care bill passed in 1985. The bill, introduced by Rep. Ruth Easterling, increases the number of children in a home from two to three before licensing is required, and removes the exemption from licensing for summer day camps run by non-profits. (The Child Day Care Commission is currently determining rules and regulations for this type of licensing. A representative of the State 4-H office will participate in the process and inform counties of the status of the regulations and implications for 4-H programs).

The legislature added 15 new staff, at a cost of \$663,000 for the biennium, to the Child Day Care section. Twelve will inspect family day care homes under the section's new licensing authority for homes, and three are added to the unit created in 1985 investigate child to abuse and neglect complaints day in care facilities.

Efforts to secure expansion funds for the Community-Based Alternatives (CBA) program were unsuccessful. Rep. David Diamont introduced a bill requesting \$2 million for the biennium, but it was not funded. Advocates were successful, however, in persuading the Human Resources Appropriations Committee to allow the program to keep \$3.2 million for biennium in funds now used for inschool suspension programs. The Basic Education Program now provides funds for these programs, and some legislators suggested that the \$3.2 million be cut from the CBA budget. The committee decided to allow the funds to be allocated for other pressing local needs.

Eliminated death penalty for anyone below the age of 17, with few exceptions.

Qualified immunity from civil liability was provided for volunteers of non-profit charitable organizations. The State 4-H Office will provide details related to this measure in a subsequent newsletter.

CBA - LOCAL PROGRAM FUNDS AVAILABLE

Enclosed in this newsletter/packet is a brochure (1 per county) which indicates regional service areas for the Community Based Alternatives program which is administered by the Division of Youth Services, Department of Human Resources. This article will briefly describe the purposes of CBA funds and their method of allocation.

Every county receives a base of \$6,000 and additional funds based on the population of youth ages 10-17. For counties to receive funds they must provide a contributing share, either 10%, 20% or 30% depending upon the county. However, this percentage matching contributions may be "inkind." Program priorities of CBA are to provide direct services which juvenile are justice related. Priorities include: providing specialized foster care and residential group homes; treatment/remediation services; and prevention sevices. The underlying concept is to target services to youth truly at risk for contact with the juvenile justice system. There are several basic by which programs are standards evaluated to determine if programs intend to target the appropriate audience. First, 90% of program recipients must be age 10-17. Next, at least one of the following four standards must be met:

35% of program recipients are referrals from juvenile court or, 50% are runaways or been in detention or, 80% have been referred for delinquent acts or status offenses (violations of juvenile code for offenses which would not be an offense if commmitted by an adult) or, if two experts identify a community as having high incidences of juvenile acts.

Approximately 15 county 4-H programs are currently recipients of CBA grants valued at a total of more than \$200,000. It seems the key to receipt of grant funds is to become active on the CBA task force at the county level. Each county is required to have a task force which looks at juvenile justice and youth indicators to determine local needs and to determine which local programs can best meet those needs. task forces are usually re-These staffed in fall or early winter each To determine who your county year. task force chairman is and to request a position on the task force contact the regional CBA coordinator as identified in the enclosed brochure.

The proposal cycle may vary somewhat from county to county but the norm seems to be:

In addition to these proposal funds, some discretionary funds are available beginning about January. These funds are available due to unused funds in some counties. The best way to know about both types of funds is to serve

on the task force.

Recent and/or proposed legislative action may make a large number of additional funds available to CBA. Now is the time to determine if these program funds can meet needs identified by your Examples 4-H program. of prevention/remediation 4-H programs which have been funded are afterschool programs, summer special interest or day camp programs, challenge camps, educational retreats, and special programs for high risk neighborhoods.

FEBRUARY OFFERS SUPER TRAINING OPPORTUNITIES

During the 4-H Volunteer Leaders and State Council Conference February 5-7, 1988 several opportunities for training of volunteers and teens will be offered. The deadline for signing up for these curriculum packages is January 10, 1988. The following is a description of some of the packages being offered:

Bicycle Training Program - The package consists of three modules: The Bicycling Environment, Hazard Awareness and Riding with Traffic. The modules are designed for 9-12 year olds and include guide, lesson a course plans, worksheets, reproducible and video programs using still photos and narration. The program was ranked first among 39 programs by the National Highway Traffic Safety Administration. This is an excellent package and is timely since the legislature has deemed necessary that bicycle safety be taught in North Carolina.

Bug Out - This package consists of 7 lessons and visual aids to support each lesson. The curriculum is geared to teach 6-12 year old youth. The lessons include Mystery Bug, Let's Look at Insects, Insects and Their Relatives, How Do They Grow, Let's Look at More In-Where Do They Live? sects and An excellent package for Everywhere. those who want to do more than make an insect collection or to better prepare them for making a collection.

Animal Science - This package is designed for 12-14 year old youth to develop sound management practices and will include lesson plans in Beef, Dairy, Dairy Goat, Swine and Sheep when completed. This training will focus on sheep and dairy and will include a kit which will facilitate the teaching experience.

Economics of Food and Fiber - is designed to give youth 6-19 an understanding or appreciation of the food and fiber system. Through selected lessons for various age groups participants will learn how the Agriculture System is: Basic to Human Needs, A Dynamic System, Interdependent upon all other segments of society, Requires continual access to Resources, A Business Interdependent with the World, Interdependent with the Environment, Influenced by the government, Requires Research and Development and is Historically significant. This is an excellent curriculum for urban areas and for those wishing to reach an older audience.

Space is limited in each of these training opportunities. There are \$50 scholarships available for members of 22 TRY teams. Please submit only one team per curriculum area. TRY Teams must have a non-agent coach and be present for the whole training (Friday night and Saturday). Remaining spaces are reserved for volunteers. This may be a good opportunity to bring on some master volunteers. The bicycle training will also have a competitive grant program where every county may apply for a \$50-\$200 grant for innovative bicycle programming. The form will be in the January newsletter.

NATIONAL 4-H COUNCIL PROGRAM ASSISTANT POSITIONS AVAILABLE

Each year National 4-H Council asks for assistance in identifying college-age 4-H alumni who would like to work at the National 4-H Center as Program Assistants facilitating the educational programs conducted by National 4-H Council.

Applicants should be mature and able to

effectively communicate with all levels of people, 4-H members, volunteers, and Extension staff, adults and youth. They should be flexible and open to change; possess an above average amount of patience; have a sense of humor; be interested in Extension and teaching in addition to having a keen interest in government, politics, and history. The individual should exemplify the finest character 4-H has to offer.

Program Assistants are paid \$3.35 per hour for 40 hours a week and time and a half for 11 hours a week for a guarantee of 51 hours of work per week. They are required to reside at the National 4-H Center. Lodging expenses of \$7.00/night which includes room, linens, weekly housekeeping service, kitchen facilities and utilities are deducted from each paycheck.

Although applications are accepted any time, applications for 1988 Spring and Summer positions must reach National 4-H Council by January 15, 1988. The three employment periods in 1988 are: February 12, May 26, and September 3. Applications should be signed by a member of the County and State 4-H Office.

DRUG PREVENTION VIDEOTAPE AVAILABLE

Illegal drug use among young people continues to be a major concern. Drug educational programs would be very appropriate for this year's State Council project. If you are planning drug programs, an excellent awareness videotape on drug prevention is now "It Can't Happen To Me" is available. aimed at students in grades 9 through 12. The 22-minute videotape was produced by the Office of Public Affairs of the Justice Department in cooperation with experts in the drug prevention field. It contains a strong, compelling message that is necessary because of the grave dangers and appalling consequences of drug use among young people.

Although an excellent message, certain terms may offend some persons. In addition, there are several instances where addicts graphically describe illnesses and deaths caused by drugs. An effort has been made to edit some of the language. However, please view the tape to determine its appropriateness for your audiences.

The tape can be ordered from the Agricultural Communications Media Library. School systems should also have a copy of the videotape. If you have questions, please call.

OPERATION RALEIGH - YOUTH EXPEDITION OPPORTUNITY

We have received an invitation from Operation Raleigh to allow 4-H'ers an opportunity to become a part of the largest international youth expedition ever mounted. Operation Raleigh was founded in 1984 by Prince Charles of England to develop leadership qualities in today's youth through three months of rigorous community service, science and adventure projects - around the world.

For the summer of 1988, Operation Raleigh USA will host a United States Expedition in three locations nationwide. These locations are Alaska, the Colorado Rockies, and the Appalachian and coastal environments.

The North Carolina General Assembly has granted a special scholarship fund for North Carolinians, aged 17-24, who participate in the United States Expedition. In addition to eligibility for general scholarship funds, a special grant has been established to provide matching funds of up to \$1,000 per participant.

The selective procedure is extensive and very time consuming. Therefore, if you are interested, please let me know as soon as possible. There are only a few selection weekends remaining. If you are interested, the time to act is now.

We are in the "countdown sequence" and proceeding with **Blue sky below my feet** here in North Carolina! Just a reminder..."Mission 1: Forces" will be broadcast over Channel 4 (the U.N.C. Center for Public Television) on Monday, January 25, 1988, from 2:30-3:00 p.m.; "Mission 2: Fibers" on Tuesday, January 26, 1988, from 12:30-1:00 p.m.; and "Mission 3: Foods" on Wednesday, January 27, 1988, from 10:00-10:30 a.m. We strongly suggest that participating schools and <u>all</u> county 4-H agents arrange to record these broadcasts even if they do not plan to implement **Blue Sky** in 1988; that way, a working copy of the program may be retained in the county 4-H office. Another note of importance: the newly-issued 1988-89 National 4-H Supply Catalog has **Blue Sky** materials listed on page 44.
